

**Initiative 2025-2026 #231: Right to public school choice – Tracked Changes Draft**

*Be it enacted by the People of the State of Colorado:*

**SECTION 1.** In Colorado Revised Statutes, **add** 22-1-151 ~~to Title 22~~ as follows:

**22-1-151. Right to public school choice.** (1) ~~EACH K-12~~ NOTWITHSTANDING ANY OTHER PROVISION OF LAW TO THE CONTRARY, EACH KINDERGARTEN THROUGH TWELFTH GRADE CHILD HAS THE FUNDAMENTAL RIGHT TO PUBLIC SCHOOL CHOICE, AS DIRECTED BY THE CHILD'S PARENT(S) OR GUARDIAN(S).

(2) PUBLIC SCHOOL CHOICE INCLUDES THE OPPORTUNITY TO ACCESS NEIGHBORHOOD DISTRICT SCHOOLS, PUBLIC CHARTER SCHOOLS, AND PUBLIC OPEN ENROLLMENT OPTIONS.

(3) IN ORDER TO ENSURE ACCESS TO THIS FUNDAMENTAL RIGHT:

(a) NEIGHBORHOOD DISTRICT SCHOOLS, PUBLIC CHARTER SCHOOLS, AND PUBLIC OPEN ENROLLMENT OPTIONS SHALL BE OPEN TO ~~K-12~~ KINDERGARTEN THROUGH TWELFTH GRADE CHILDREN WITHOUT THE PAYMENT OF TUITION;

~~(b)~~ (b) NOTWITHSTANDING THE "CHARTER SCHOOLS ACT," PART 1 OF ARTICLE 30.5 OF THIS TITLE, IF A CHARTER SCHOOL'S APPLICATION OR RENEWAL IS DENIED BY THE LOCAL SCHOOL DISTRICT BOARD OF EDUCATION, THE CHARTER SCHOOL MAY APPEAL TO THE STATE BOARD OF EDUCATION AND, IN THE ABSENCE OF AN APPEAL, SHALL ~~MUST~~ BE RELEASED TO THE COLORADO CHARTER SCHOOL INSTITUTE, AN INDEPENDENT STATE AGENCY CREATED PURSUANT TO SECTION 22-30.5-503, WHICH MAY DENY OR APPROVE THE SCHOOL'S APPLICATION; AND

(c) OPEN ENROLLMENT IN PUBLIC SCHOOLS ~~SHALL~~ MUST REMAIN AVAILABLE TO ~~K-~~ KINDERGARTEN THROUGH TWELFTH GRADE CHILDREN UNDER STATE LAW AS SPACE ALLOWS.

**SECTION 2. Effective date.** This act takes effect on the date of the proclamation of the Governor announcing the approval, by the registered electors of the state, of the proposed initiative and shall apply as of the effective date regardless of prior existing law.
